The Society continued to advance geography and people's understanding of its contributions to the challenges facing our planet through a variety of projects, including: a vibrant programme of activities that included regular presentations in-person and via Zoom, a series of interactive public forums, and day and multi-day trips within Australia our work with geographical education, including the Australian Geography Competition which over 60,000 secondary students entered in 2023, taking Australia's team to the International Geography Olympiad, and presenting awards to high-achieving university students launch of a web-based catalogue of our nationally significant collections (books, journals, maps and images) to be publicly searchable via e-Hive conservation of books and maps via funding from Community Heritage Grants support of the the Soils for Science (S4S) citizen science project collaborating with multiple organisations, including the University of Queensland (UQ), Binna Burra Lodge (BBL), and the State Library of Queensland (SLQ)
